## The Text of the Agreement between Belgium, Denmark, the Federal Republic of Germany, Ireland, Italy, Luxembourg, the Netherlands, the European Atomic Energy Community and the Agency in Connection with the Treaty on the Non-Proliferation of Nuclear Weapons

### Accession of the Czech Republic

1. Article 23(a) of the Agreement<sup>1</sup>, and the Protocol thereto, between Belgium, Denmark, the Federal Republic of Germany, Ireland, Italy, Luxembourg, the Netherlands, the European Atomic Energy Community and the Agency in implementation of Article III, (1) and (4) of the Treaty on the Non-Proliferation of Nuclear Weapons (NPT)<sup>2</sup> provides that the Agreement shall come into force for non-nuclear-weapon States Party to NPT which become members of the European Atomic Energy Community upon:

- (i) Notification to the Agency by the State concerned that its procedures with respect to the coming into force of the Agreement have been completed; and
- (ii) Notification to the Agency by the European Atomic Energy Community that it is in a position to apply its safeguards in respect of that State for the purposes of the Agreement.

2. The Agreement and the Protocol thereto, which came into force for the above-mentioned original signatories on 21 February 1977<sup>3</sup>, have also entered into force for Austria<sup>4</sup>, Bulgaria<sup>5</sup>, Cyprus<sup>6</sup>, Estonia<sup>7</sup>, Finland<sup>8</sup>, Greece<sup>9</sup>, Hungary<sup>10</sup>, Latvia<sup>11</sup>, Lithuania<sup>12</sup>, Malta<sup>10</sup>, Poland<sup>13</sup>, Portugal<sup>14</sup>, Slovakia<sup>7</sup>, Slovenia<sup>15</sup>, Spain<sup>16</sup> and Sweden<sup>17</sup>.

3. The Agency received from the Czech Republic on 18 May 2009 and from the European Atomic Energy Community on 1 October 2009, the notifications required by Article 23(a) of the Agreement. Accordingly, the Agreement entered into force for the Czech Republic on 1 October 2009.
