Communication from the Permanent Missions of Brazil and Romania to the International Atomic Energy Agency regarding Guidelines for the Export of Nuclear Material, Equipment and Technology

- 1. The Director General of the International Atomic Energy Agency has received Notes Verbale from the Permanent Missions of Brazil and Romania, dated 28 February 2003, providing information on the export policies and practices of the Governments of Brazil and Romania with respect to the export of nuclear material, equipment and technology.
- 2. In the light of the wish expressed at the end of each Note Verbale, the text of the Notes Verbale is attached. The attachment referenced in the Notes Verbale was issued previously as INFCIRC/254/Rev.6/Part 1.

The Permanent Mission of Brazil presents its compliments to the Director General of the International Atomic Energy Agency (IAEA) and has the honour to refer to its Note Verbale, dated 31.08.01, concerning the decision of the Government of Brazil to act in accordance with the Guidelines for Nuclear Transfers currently published as document INFCIRC/254/REV.5/Part1 (Corrected), including its Annexes.

The Government of Brazil has decided to amend the Guidelines and its Annexes in order to address the threat of nuclear terrorism. Accordingly, paragraphs 8, 10, 11 and 13 of the Guidelines and the TECHNOLOGY CONTROLS section in Annex A have been revised to include amendments regarding nuclear terrorism.

In the interest of clarity, the complete text of the modified Guidelines and its Annexes is reproduced in the attachment, as well as a "Comparison Table of Changes to the Guidelines for Nuclear Transfers (INFCIRC/254/R.5/Part 1 (Corrected)."

The Government of Brazil has decided to act in accordance with the Guidelines so revised.

In reaching this decision, the Government of Brazil is fully aware of the need to contribute to economic development while avoiding contribution in any way to a proliferation of nuclear weapons or other nuclear explosive devices or the diversion to acts of nuclear terrorism, and of the need to separate the issue of non-proliferation or non-diversion assurances from that of commercial competition.



The Government of Brazil, would be grateful if the Director General of the IAEA would bring this Note and its attachment to the attention of all Member States.

The Permanent Mission of Romania to the International Organizations in Vienna presents its compliments to the Director General of the International Atomic Energy Agency (IAEA) and has the honour to refer to its Note Verbale of 20 October 1999 concerning the decision of the Government of Romania to act in accordance with the Guidelines for Nuclear Transfers of Nuclear-Related Dual-Use Equipment, Material and Related Technology currently published as document INFCIRC/254/Rev.4/ Part 2, including its Annexes.

The Government of Romania has decided to amend the Guidelines to address the threat of nuclear terrorism. Accordingly, paragraphs 1, 2 and 4 of the Guidelines have been revised to include amendments regarding nuclear terrorism.

The Government of Romania has also decided to amend the Annex to the Guidelines to clarify a technical point. Accordingly, a technical note describing the meaning of the phrase "linear displacement" has been added to Annex Item l.B.3.b.
