

Communication Received from Switzerland Concerning its Policies Regarding the Management of Plutonium

- 1. The Secretariat has received a note verbale dated 6 February 2018 from the Permanent Mission of Switzerland to the IAEA in the enclosures of which the Government of Switzerland, in keeping with its commitment under the Guidelines for the Management of Plutonium (contained in INFCIRC/549¹ of 16 March 1998 and hereinafter referred to as the "Guidelines") and in accordance with Annexes B and C of the Guidelines, has made available annual figures for its holdings of civil unirradiated plutonium and the estimated amounts of plutonium contained in spent civil reactor fuel as of 31 December 2017.
- 2. In light of the request expressed by the Government of Switzerland in its note verbale of 1 December 1997 concerning its policies regarding the management of plutonium (INFCIRC/549 of 16 March 1998), the note verbale of 6 February 2018 and the enclosures therewith are attached for the information of all Member States.
