Group of Friends for Women in Nuclear – Establishment Document

The group of Friends for Women in Nuclear was announced on 15 June 2017 at a meeting of the International Atomic Energy Agency (IAEA) Board of Governors (BOG). The Group has been formed to promote a collective effort to increase, through practical initiatives, the representation of women in the IAEA Secretariat.

Membership

Founding members of the Group of Friends for Women in Nuclear are Australia, Costa Rica, France, Ireland, Lithuania, Mexico, New Zealand, Norway, Slovenia, South Africa, Sweden, Turkey, the United Kingdom and the United States of America.

Membership in the Group is open to all member states of the IAEA upon application. A member state interested in joining the group should make their interest known to one of the Group's co-chairs.

The IAEA Secretariat has agreed to participate in the work, meetings and consultations of the Group.

Terms of Reference

The Terms of Reference and objectives of the Group of Friends for Women in Nuclear are not fixed and are expected to evolve over time.

A permanent objective of the Group is, however, to increase to parity the representation of women in the IAEA Secretariat. To achieve this aim, the Group will develop practical initiatives able to help shape relevant IAEA practices and culture, and also the relevant practices of member states, to promote gender equality and parity, including at senior management levels.

The Group will establish a regular channel of communication with the IAEA on questions of gender and the representation of women at all levels and in all functions of the Agency's operations.

It will support the IAEA in identifying barriers to the recruitment and advancement of women and work with the Agency in looking to address these.

Members of the Group also commit themselves to:

- Improve gender equity in their own delegations to IAEA meetings;
- Work with their domestic industries and within their governments to increase the number of women available for recruitment to the IAEA; and
- Share best practice on policy and practical initiatives.

The group will complement other initiatives also aimed at raising awareness about, and realising gender parity – including the Vienna chapter of the *International Gender Champions Initiative*.

Meeting schedule

The Group of Friends for Women in Nuclear will meet in advance of each Board of Governors meeting. Co-chairs will co-ordinate to organise these meetings.

Co-chair arrangements

Founding co-chairs of the Group of Friends for Women in Nuclear are Australia and Mexico. There are no fixed co-chair terms, and co-chair arrangements may change from time to time on agreement of the incumbent co-chairs in consultation with the broader Group.

Links to other groups

Where it makes sense to do so, the Group of Friends for Women in Nuclear will seek to engage with, and will support the work of other groups with a shared interest in promoting gender equality and parity. This includes the *International Gender Champs Initiative*.
