## Communication dated 25 July 2022 received from the Permanent Mission of Ukraine to the Agency

The Permanent Mission of Ukraine to the International Organizations in Vienna presents its compliments to the Secretariat of the International Atomic Energy Agency and has the honour to communicate the following.

Recently the Russian occupiers have significantly intensified repressions, terror, abuse and torture against the personnel of the Zaporizhzhia Nuclear Power Plant, as well as other activities that undermine the nuclear safety and security regime in an unprecedented manner.

In particular, on 20 July 2022, the Russian occupiers demanded to open the transport corridors of the turbine sections of the first, second and third power units of the Zaporizhzhia NPP in order to place military

equipment, weapons and explosive materials there.

Such actions significantly increase the probability of the detonation of Russian explosives in the immediate vicinity of the large volumes of oil and hydrogen stored there and the working equipment of the power units. This can lead to the destruction of the load-bearing structures and the coating in a matter of minutes, as well as large-scale destruction of the machine halls.

At least 14 units of heavy military equipment with ammunition, weapons and explosives are currently located in the engine room of the first power unit of the Zaporizhzhia NPP. The entire arsenal of Russian heavy equipment with all ammunition is currently located very close to the equipment that ensures the operation of the turbogenerator. In particular, in the immediate vicinity of the main oil tank, which contains flammable oil that cools the steam turbine. There is also explosive hydrogen, which is used to cool the generator.

The military equipment of the Russian occupiers prevents the access of specialized fire engines and other vehicles to the control room of power unit number one. Therefore, the risk of fire increases while its extinguishing

becomes extremely problematic.

A day earlier, on 19 July 2022, two representatives of the Russian occupying forces, using the passes forcefully taken from the station employees, entered the controlled zone of the Zaporizhzhia NPP (the middle overpass), where they stayed for a certain time for unidentified reason.

Such actions constitute a gross violation of radiation safety regime and can cause radiation pollution of the NPP and personnel due to the movement of radioactive pollutants from the controlled zone to the clean zone on the clothes of the occupiers.

Zaporizhzhia NPP employees.

The Russian occupiers seized the premises of the canteen No. 18 of the Zaporizhzhia NPP. Threatening the NPP workers with weapons, the occupiers took them out of the canteen and announced that from now on the Zaporizhzhia NPP employees were prohibited from entering the canteen. As a result of the takeover of the canteen by the occupiers, the workers have no opportunity to eat now, which negatively affects their moral and psychological state and health.

In addition, according to the information of the competent authorities of Ukraine, since the beginning of the occupation of the Zaporizhzhia NNP, the servicemen of the Russian occupying forces used physical and psychological pressure and other repressive measures against

42. Mr Oleksandr Mardar, employee of the physical protection service, interrogated with the use of physical impact measures, now

released.

43. Mr Vitaliy Troyan, head of the 13<sup>th</sup> Squad of the State Emergency Service, kidnapped on 18.05.2022, measures of physical influence were applied, forced to record a propaganda video message, released on 21.06.2022.

Russia must withdraw its troops and weapons from the territory of the Zaporizhzhia NPP and stop preventing Ukrainian nuclear workers from fulfilling their obligations in the field of nuclear and radiation safety in accordance with international conventions, as well as current norms and standards of the IAEA.

The Permanent Mission of Ukraine requests the Secretariat of the International Atomic Energy Agency to promptly circulate this Note Verbale as Information Circular to all IAEA Member States.
